SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Flammable liquids (Category 2). Highly flammable liquid and vapor (H225). Keep away from heat, sparks, open flames, and hot surfaces. No smoking (P210).

Hazard class: Acute toxicity, oral (Category 4). Harmful if swallowed (H302). Do not eat, drink or smoke when using this product (P270).

Hazard class: Skin and serious eye damage, corrosion or irritation (Category 2, 2A). Causes skin and serious eye irritation (H315+H319).

SECTION 4 — FIRST AID MEASURES

If exposed or concerned: Get medical advice or attention (P308+P313).

If inhaled: Remove victim to fresh air and keep at rest in a position comfortable for breathing.

SECTION 5 — FIRE FIGHTING MEASURES

Class IIIA combustible liquid.

Flash point: 62 °C

When heated, releases flammable fumes.

In case of fire: Use a tri-class dry chemical fire extinguisher.

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Organic #8. Store with phenols and cresols.

Keep container tightly closed. Store in a cool, dry place. Use only in a hood or well-ventilated area (P271).

SECTION 8 — EXPOSURE CONTROLS, PERSONAL PROTECTION

Wear protective gloves, protective clothing, and eye protection (P280). Wash hands thoroughly after handling (P264). Use only in a hood or well-ventilated area (P271). Will stain skin, clothing, and surfaces.

Exposure guidelines:(as phenol) PEL/TLV 5 ppm (OSHA, ACGIH) Odor threshold of phenol is 0.04 ppm.

SECTION 9 — PHYSICAL AND CHEMICAL PROPERTIES

Rose to purple liquid. Strong phenol odor.

Used to stain acid-fast bacteria.

Avoid heat and sources of ignition. Avoid body contact.

Shelf life: Indefinite, if stored properly.

SECTION 11 — TOXICOLOGICAL INFORMATION

Acute effects: Skin and respiratory irritant. Harmful if swallowed.

ORL-RAT LD₅₀: 317 mg/kg (as phenol)

Chronic effects: Bladder cancer. Basic fuchsin is an IARC-2B carcinogen.

IHL-RAT LC₅₀: 316 mg/m³ (as phenol)

SKN-RBT LD₅₀: 850 mg/kg (as phenol)

Target organs: Bladder, lungs, skin.
