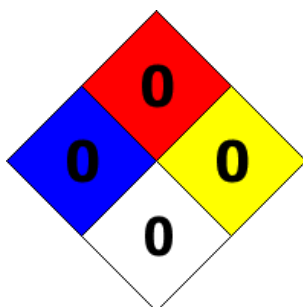

Methods and material for containment and cleaning up:

Keep in suitable closed containers for disposal. Wear protective eyewear, gloves, and clothing. Refer to Section 8. Always obey local regulations. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration.
